Objective

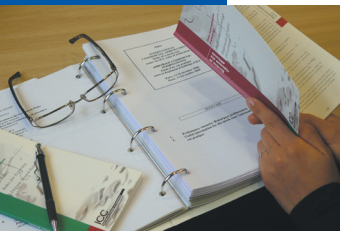
