Purpose of this conference

Entering into effect at the end of 2011, the new ICC Arbitration Rules 2011 will bring about considerable changes to the ICC's arbitral proceedings. Increased efficiency, reduction of cost, enhanced protection of fundamental procedural rights, & the electronic handling of arbitration have been key issues in focus.

Every arbitration practitioner must acquaint himself/herself with the new ICC Rules of Arbitration. While maintaining the traditional advantages of ICC arbitration, they present a series of innovations in particular regarding multiparty scenarios, the initiation phase & the ability to obtain interim measures of relief from an emergency arbitrator even before the Arbitral Tribunal is constituted.

The new rules will be introduced by their drafters, who will discuss the genesis & purpose of the various provisions and provide first-hand knowledge.

The ICC International Court of Arbitration is the world's leading institution for resolving international business disputes. In 2009 alone, 817 cases were filed, involving 2,095 parties from 128 countries. Vienna has been the place of arbitration in 25 of these cases, putting Vienna next to Paris, London, Geneva & Zurich amongst European venues. Vienna is proud to host one of the first events launching the ICC Rules 2011 world-wide.
