Trafficking of women and children

What can international lawyers do to help solve or reduce the epidemic?

The trafficking of women and children or *de facto* slavery is increasing across and within international borders. UN estimates indicate that more than four million people are trafficked each year. It is a problem that faces both developed as well as developing nations, with many lives ruined and the perpetrators not usually brought to justice. This session continues the Women Lawyers' Interest Group activities to raise awareness of the scale of the problem, and to reduce its prevalence. The session will have high-level multi-disciplinary speakers to provide information on the scope of the problem and what can be done by international lawyers to help alleviate it, individually and through organisations and governments. Particular attention will be given both to recent international initiatives on the issue, such as those of the UN and the Council of Europe.

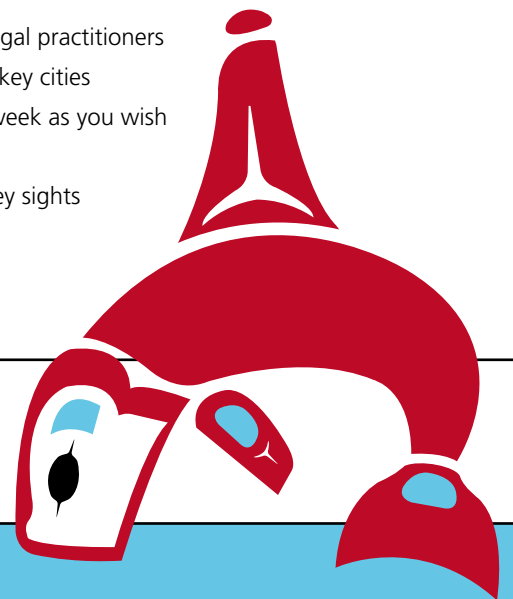
