Case Study – Rio Tinto/BHP Billiton

On June 2009, mining giants BHP Billiton and Rio Tinto entered into a joint venture agreement to combine their Western Australian iron ore assets. The deal was subject to a number of conditions, including regulatory approvals in several jurisdictions, and faced substantial worldwide opposition from antitrust authorities and competitors, mainly in China and Japan. After a year and a half of trying to demonstrate the pro-competitive effects of the transaction, the companies decided to terminate their joint venture. This panel will bring together counsels for both Rio Tinto and the Japanese steel companies which opposed the deal, in a lively debate on the main issues raised in the case, including some fascinating aspects such as extra-territorial jurisdiction, economic analysis, and international cooperation among agencies.

Other institutions established by the IBA include the **Southern Africa Litigation Centre** and the **International Legal Assistance Consortium**.

Antitrust Committee overview

The Antitrust Committee provides an international forum for the exchange of the most current thinking in the field of antitrust law. In addition, there is a strong commitment to bring together international practitioners to facilitate closer working relationships. The committee is increasingly relied upon by government officials and members of the private sector for its expertise and practical input into antitrust developments.

The Antitrust Committee forms working groups to study major international competition policy issues and to submit comments to regulators on proposed new and reformed legislation.

The Antitrust Committee works with the following committees to form the Antitrust and Trade Law Section:

- Global Forum for Competition and Trade Policy
- Trade and Customs Law Committee

European Regional Forum overview

The European Regional Forum was established in 1989 to provide a focus originally on the work undertaken by the IBA in developing the practice under changing legal systems of lawyers in Eastern and Central Europe.
